



SGS has been contracted by Chicony Power Technology Co., Ltd. (hereinafter referred to as "Chicony Power"), 21F, 23F-30F, No.69, Sec. 2, Guangfu Rd., Sanchong Dist., New Taipei City 241, Taiwan (R.O.C.) for the verification of direct and indirect Greenhouse Gas emissions in accordance with

ISO 14064-3: 2006

as provided by Chicony Power Technology Co., Ltd. (hereinafter referred to as "Chicony Power"), 21F, 23F-30F, No.69, Sec. 2, Guangfu Rd., Sanchong Dist., New Taipei City 241, Taiwan (R.O.C.), in the GHG Assertion in the form of GHG report covering GHG emissions of the period 01 January 2018 to 31 December 2018.

#### Roles and responsibilities

The management of Chicony Power is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is SGS's responsibility to express an independent GHG verification opinion on the GHG emissions as provided in the GHG Assertion for the period 01 January 2018 to 31 December 2018.

SGS conducted a third party verification of the provided GHG assertion against the principles of ISO 14064-1:2006, ISO 14064-3:2006 in the period 10 April 2019 to 22 April 2019. The verification was based on the verification scope, objectives and criteria as agreed between Chicony Power and SGS on 24 December 2018.

#### Level of Assurance

The level of assurance agreed is that of reasonable assurance.

#### Scope

Chicony Power has commissioned an independent verification by SGS Taiwan of reported GHG emissions of Chicony Power arising from Design, production and sale of motors activities, to establish conformance with ISO 14064:2006 principles within the scope of the verification as outlined below.



This engagement covers verification of emission from anthropogenic sources of greenhouse gases included within the organization's boundary and is based on ISO 14064-3:2006.

- Location/boundary of the activities:

- The IPCC 2007 AR4 GWP values are applied in this inventory.
- Electricity emission factor: 0.554 kgCO<sub>2</sub>e/kwh
   (Announced by Bureau of Energy, Ministry of Economic Affairs in 2018)
- Directed actions: NA
- GHG information for the following period was verified: 01 January 2018 to 31 December 2018
- The version of inventory sheet: V2

#### **Objective**

The purposes of this verification exercise are, by review of objective evidence, to independently review:

- Whether the GHG emissions are as declared by the organization's GHG assertion
- The data reported are accurate, complete, consistent, transparent and free of material error or omission.

#### Criteria

Criteria against which the verification assessment is undertaken are the principles of ISO 14064-1:2006

#### Materiality

The materiality required of the verification was considered by SGS to 5%, based on the needs of the intended user of the GHG Assertion.

#### Conclusion

Chicony Power provided the GHG assertion based on the requirements of ISO14064-1: 2006. The GHG information for the period 01 January 2018 to 31 December 2018 disclosing emissions of 1,473.798 metric tonnes of CO<sub>2</sub> equivalent and 0.0000 metric tonnes of direct CO<sub>2</sub> emissions from the combustion of biomass are verified by SGS to a reasonable level of assurance, consistent with the agreed verification scope, objectives and criteria.

SGS's approach is risk-based, drawing on an understanding of the risks associated with reporting GHG emissions information and the controls in place to mitigate these. Our examination includes assessment, on a test basis, of evidence relevant to the amounts and disclosures in relation to the organization's reported GHG emissions.

We planned and performed our work to obtain the information, explanations and evidence that we considered necessary to provide a reasonable level of assurance that the GHG emissions for the period 01 January 2018 to 31 December 2018 are fairly stated.

We conducted our verification with regard to the GHG assertion of Chicony Power which included assessment of GHG information system, monitoring and reporting plan/protocol. This assessment included the collection of evidence supporting the reported data, and checking whether the provisions of the protocol reference, were consistently and appropriately applied.

In SGS's opinion the presented GHG assertion

- is materially correct and is a fair representation of the GHG data and information, and
- is prepared in accordance with ISO14064-1:2006 on GHG quantification, monitoring and reporting.
